PASTOR'S ANNUAL LETTER 2011

"So that at the name of Jesus every knee should bend, in heaven and on earth and under the earth, and every tongue should confess that Jesus Christ is Lord, to the glory of God the Father." (Philippians 2:10-11)

As you read through the various reports about our church family, you will see that indeed God is active among us, and using this church to make a difference in the Las Cruces community. Through the ministries of our Deacons and others, we have fed many who were hungry, provided clothing for those in need, backpacks and school supplies for children returning to school, and extended Christian compassion in many other ways. Our Sunday school classes and the Salt & Light program are thriving. Faith and Fellowship, our second worship service held on Saturday evenings continues to touch human lives and invite people into a deeper relationship with Jesus Christ. Being able to accompany our high school group on their mission trip to New Orleans was another assurance that God is definitely up to something here at First Presbyterian Church.

For the first time since I became a pastor, a member of the church I serve has felt called to become a Presbyterian pastor and that the Session has joyfully endorsed that journey. In addition, three other elders of our congregation have spoken to me about being trained to become Lay Pastors, commissioned to serve in our Presbytery. Clearly, the Lord is touching lives and accomplishing some wonderful things here. What an exciting time this is for us!

At the same time, these are complex and challenging times for the churches of our denomination. The turmoil and uncertainty over human sexuality issues in our world and culture are raising questions, differences and conflicts within our denomination that will probably not be resolved quickly or easily. It is my privilege to serve as our Presbytery's minister-commissioner to our next General Assembly in June. I look forward to participating in our denomination's process of discerning God's will. I believe the challenge before us, is to keep our focus on Jesus Christ and our mission, and not be distracted by toxic issues that would disrupt and divide us. For this congregation in particular, our principal task is to continue to live-out the Good News of Jesus Christ in ways that reflect and proclaim God's truth, grace and mercy, and that make a difference here in Las Cruces.

The Philippians passage that began this letter assures us of the Church's certain victory in Jesus Christ. We are all sisters and brothers in Christ, even when we disagree in significant ways. Perhaps that is why according to chapter 17 of the Gospel of John, Jesus prayed this to his Father in the Garden of Gethsemane: "As you have sent me into the world, so I have sent them into the world that they may all be one. ... The glory that you have given me I have given them, so that they may be one, as we are one, I in them and you in me, that they may become completely one, so that the world may know that you have sent me and have loved them even as you have loved me."

These are indeed interesting times, and truly the best is yet to come!

The Christian Education ministry of First Presbyterian Church has had many blessings this last year. Even with financial constraints, the ministry continues to grow within our fellowship and out into the community. The education ministry at First Presbyterian continues to flourish through a dedication of many volunteers called to use their gifts in the many programs we offer.

Sunday School is offered every Sunday from birth to adults. The birth-kinder program is being led by Judith Ames and Carol Goss. It was a very productive and fun weekend and we are looking forward to being able to do a mission trip to the Navajo reservation this year.

The High school group spent their mission trip in New Orleans. We did a lot of service work and time getting to know a lot of the people in the area. It was not what a lot of the youth expected but it did open the eyes of a number of our youth about what the situation is there and for one youth received a calling to ministry. Mission trips aren't always about building things where we go but what we learned along the way. We were able to build a stronger bond with God and each other that cannot be duplicated no matter what we may do here. That is why our fundraisers are so important to this youth group. It allows us to go to places and do things that we just can't do here as effectively. That is why we had 12 fundraisers this past year so that we can go on these trips and be a help to others but also have our students and often our leaders be touched by what God is calling them to do.

One of the things that have been encouraging is the involvement the youth have had this past year in leading worship. Besides the liturgist every month on the third Sunday they also ran 3 different services this past year. This would include the sermon, music, liturgy, and presenting all of these during the service. They were all very well received and the youth were excited to do all of these. The youth were also very active in helping those in the church that needed help. For instance we helped a couple of people decorate their house for Christmas because of their physical limitations. We also helped clean up some houses, yards, and moved some large items for those that said they needed it. They were also very involved in helping around the area by volunteering at the Gospel Rescue Mission a number of times and food drives for the soup kitchen.

Possibly even being a mentor could mean a great deal and make and impact on the rest of their lives. This is a job that no one person can do alone so please prayerfully considers volunteering to help the next generation.

The other thing that we need is prayer. This is by far the most important thing that we need this year. Specifically prayers as stated in the previous paragraph for more adult leaders, but also more leaders that will rise out of the youth themselves. Prayer is the thing that will get us through the next year and continue to grow what is going on here at First Presbyterian Church. God Bless all of you in the coming year,
